Eligibility: This is a SCRATCH ONLY EVENT .Open to all female amateur golfers with a current **USGA Handicap Index of 7.0 or less.**

Entry Fees/Registration:

\$160.00 per person - For two (2) days, entry includes green fees, range balls for both days and awards. **The entry does not include power carts. Field is limited to the first 40 paid entries. All others will be placed on a waiting list.**

Cancellations:

No refunds after the closing date July 5 2017. Cancellations and requests for a refund **prior** to the closing date may call Tournament Director Marc Arcuri at (916) 770-5627 / (916) 771-3939. **Please do not call the Golf Course for cancellations.** There will be a \$25.00 service charge on all returned checks and a \$10.00 fee assessed for ANY cancellations.

Format: Stroke Play over 36-holes. In the event of a tie, a sudden-death playoff will be conducted after completion of play on Sunday, July 16, 2017.

Awards: The Champion will have her name inscribed on this tournament's perpetual trophy. Presentation of awards will take place immediately following the conclusion of the tournament on Sunday.

Rules: Governed by the USGA Rules of Golf and its decisions and Local Rules posted by the Committee prior to play. The Tournament Committee will rule on all Rules Questions. **Pace of Play Policy will be enforced.** The use of cellular phones or pagers during the event is discouraged or must be in the off position. GPS devices may be used for distances only.

UNSPORTSMANLIKE CONDUCT – The use of abusive language, throwing of golf clubs, or other disruptive behavior is not allowed. – PENALTY: DISQUALIFICATION

Please no metal penetrating golf shoe spikes.

Times: Competitors are responsible for knowing their tee times and checking in at a registration table at least 20 minutes prior to their starting time. Tee times will be made available by calling Ancil Hoffman GC, 482-3813 on Tuesday, July 12, 2017, or at the Sacramento Golf Council website: www.sacgolfcouncil.org.
