



# 42nd Annual Sacramento County Women's Golf Championship

Saturday & Sunday, April 24 & 25, 2010

**Eligibility:** Open to all female amateur golfers with a current USGA Handicap Index. **Handicap Flights** will be played at current handicap. The Championship Flight will play at scratch. The Tournament Committee will access current handicap indexes prior to the tournament. Handicap verification may be required in event handicap indexes access were not available by the tournament date.

**Entry Fees/Registration:**

\$120.00 per person - For two (2) days, entry includes green fees for both days and awards. **The entry does not include power carts.** A signed entry form indicates your willingness to abide by the Rules of Golf and all decisions made by the Tournament Committee. Field is limited to paid entries from the first 144 players. Power Carts may be reserved by calling the Ancil Hoffman Golf Shop at (916) 482-3284.

Please visit [www.sacgolfcouncil.org](http://www.sacgolfcouncil.org) if you would like to register and pay online; or you can mail this completed entry form (see mailing instructions below) with a check made payable to the "Sacramento Golf Council" for \$120. **The deadline to register by mail is 5 p.m. April 14** and the **deadline to register online is 10 p.m. April 16, 2010.**

**Cancellations:** No refunds after the closing date April 16, 2010. Cancellations and requests for a refund **prior** to the closing date may call Tournament Director Charlotte Wells at

916 803.2960 **Please do not call the Golf Course for cancellations.** There will be a \$20.00 service charge on all returned checks and a \$10.00 fee assessed for ANY cancellations.

**Format: Stroke Play over 36-holes.** 18-holes on Saturday and Sunday April 24 & 25, 2010. The Championship Flight will play at **Scratch**, other flights will play at handicap. **Handicap flights** will be determined by the number of entries and handicap spread. In the event of tie(s) in the Championship Flight, a sudden-death playoff will be conducted after completion of play on Sunday, April 25, 2010. All other ties will be decided by the recommended USGA method of determination, **(last nine, last six, last three and last hole on scorecards in that order).**

**Awards:** The low gross Champion will have her name inscribed on this tournament's perpetual trophy. Each Division Champion will receive an individual championship trophy and a gift card redeemable at any Sacramento County Golf Course. All other winners will receive gift cards also. Presentation of awards will take place immediately following the conclusion of tournament on Sunday. Winner gift cards for those not present will be mailed.

**Rules:** Governed by the USGA Rules of Golf and its decisions and Local Rules posted by the Committee prior to play. The Tournament Committee will rule on all Rules Questions. **Pace of Play Policy will be enforced.** The use of cellular phones or pagers during the event are discouraged or must be in the off position. GPS devices may be used for distances only.

**UNSPORTSMANLIKE CONDUCT** – The use of abusive language, throwing of golf clubs, or other disruptive behavior is not allowed. – PENALTY: DISQUALIFICATION

**Please no metal penetrating golf shoe spikes.**

**Times:** Competitors are responsible for knowing their tee times and checking in at a registration table at least 20 minutes prior to their starting time.
